

## Running for public office

If you considering running for public office, I hope the following will be of assistance to you. One thing to always remember: all politics are local and we can cure most of the mechanisms destroying this country at the local and state levels. Not all, but most.

Not all elected offices are political, i.e., the office you're running for is one candidate of one party against another. These are elected offices like city council, sheriff, school board, water district.

All the states, cities and county have different rules, laws, procedures and criteria for running. The first thing to do is read your State Constitution, the U.S. Constitution and as many historical founding documents as you can.

Next is to identify the office you feel comfortable running for and get a job description for that elected office.

Congressional level: There are [age requirements](#) for the House of Representatives and U.S. Senate.

Regarding the election of U.S. Senators: The Seventeenth Amendment to the U.S. Constitution was never ratified. The fraud involving this big lie is far worse than all the verifiable evidence on the Sixteenth. Voting for U.S. Senators is voting for individuals who have no legal right to run because they are running under a law that does not exist. I have not voted for a U.S. Senate candidate for over ten years because I will not participate in fraud.

I have been to the National Archives in Washington, DC many times. I have seen how two Secretary's of State, Philander Chase Knox and William Jennings Bryan committed fraud. For federal level offices, contact the elections division at the Secretary of State's office in

your state. There is up to a one year residency requirement along with other rules set forth by your state legislature that must be adhered to, otherwise you may not get qualified in time. Watch those dates. Besides registering at your Secretary of State's office for your candidacy, you must also register with the [Federal Elections Commission](#) in Washington, DC.

For state offices, i.e. the state legislature, attorney general, governor, again, you would contact the elections division at the Secretary of State's offices. All states have different requirements and dates for filing of their dozens of regulations and requirements. Watch those dates.

For county offices, i.e., county recorder, sheriff, county board of supervisors, lower court judges: contact your county election board.

For city offices, i.e., city council, mayor: contact the city election commission. If you don't know how to do this, call the mayor's office and ask them how to contact the elections office which governs elections within the city. You don't need to explain what your goal is - like replacing the current mayor!

### **Money and the parties.**

The Republican and Democrat parties are well greased machines. Both are corrupt beyond most people's comprehension. It is up to the 80 million members of both of those parties to either clean them up or get out, join another party and work to make them viable competitors. The four major parties in these united States of America that are registered in all 50 states or most of them are Republican, Democrat, Constitution and Libertarian. Do a google search to find the national party headquarters web site to read their platforms.

The higher the office, the more money required. Candidates for Governor obscenely spend tens of millions of dollars. The party picks *their* choice to advance the agenda regardless of what the people want. The people must lay down the law to their state party leadership. If the Republican party continues to shove new world order, anti-American candidates and incumbents as the only choice for voters in your state- withdraw your support from the party. The party needs you, not the other way around. It is your right to run for any level office you want to challenge and don't let anyone intimidate you with party rhetoric or threats.

It costs relatively little money to run for school board, water district, county board of supervisor, city council, sheriff (smaller towns and cities) and mayor. Depending on the size of the city or town you live in, you can still beat the incumbent state rep or senator if you run a well organized campaign. You will be shocked to see how many available offices have no candidate running for them! Let's get out there and fill them.

If you come out with a platform that is in keeping with the duties of the office, present yourself well and walk your precinct, the voters will respond and the money will come. I

know because I ran for Congress twice with no bribe money (special interest PACs). If you take money once, you will take it again and then it gets easier and easier. There are only two members of the U.S. Congress who don't allow lobbyists in their offices to attempt to bribe them for votes. The American people are fed up with corrupt, rotten politics and politicians. Campaign finance is a joke. As long as members of Congress and the state legislatures accept political action committee (PAC) money and big corporation dollars - which are nothing more than bribes - the special interests will continue to rule our political process.

### **Personal Presentation**

First impressions are everything because you may not get a second chance. A person doesn't need a million dollar ward robe to resonate with voters. What a candidate does need though is to look nice, leave out conspiracy theories and don't treat your voters with contempt just because they don't know what you do. Because the so-called "mainstream media" in this country is completely controlled, most Americans have not been exposed to the big picture like you and me. Get elected and then begin educating.

Regardless of what level office you seek, I can tell you from personal experience, you must walk your precincts. Establish a personal presence in your district. If you're a woman, don't do this alone, always have someone with you. The two legged predators are on the prowl and unless you carry a gun, always travel with another person. You must attend as many functions as you can, i.e. breakfasts at the Chamber of Commerce, lunch at Lion's Club meetings and that sort of thing.

Make it a point to challenge your opponent on a regular basis to debates. Contact your local newspaper and ask them to sponsor a debate so the voters have a chance to get to know the candidates. This makes a difference. At one debate when I ran for Congress (1996), the incumbent, Congressman Wally the Waffle Herger, didn't show. He scurried back to DC because I wiped him all over the floor in the prior debate over NAFTA. Herger was the favorite going into the debate according to the newspaper's polling of the 250 attendees. After the debate (there were two other candidates who also debated), 96% of the attendees said they would vote for me on election day.

We are the government - federal, county, state, city. If we the people don't fill all these offices, the same people who are currently serving that are destroying our way of life and our Republic will remain in office.

One thing I can promise you: running for public office regardless of what office is an enriching, frustrating experience you will never forget, but will be richer for making a contribution even if you don't win. You *can* be the harbinger of the truth and solutions to millions of Americans. Let's make Operation Clean Sweep a tidal wave movement in
